4. Details of our assessment

Unannounced site inspection undertaken by Jolene Lewis and David Morgan of Natural Resources Wales.

General Management (W1A)

Officers requested a copy of the Environmental Permit and The Environmental Management System. The permit was made available but was not easily located.

Action- To ensure all staff have easy access to permit and working plan. As per permit conditions 1.3.1

Operations (W2A) (W2C) (W2D)

Waste was separated and waste types on site were in line with permit condition 1.2.

Site drainage at rear of green shed was well maintained and site drainage at time of visit was in good working order. While on site we discussed the potential installation of a new drainage system in the future as this would prevent surface water being discharged to ground.

At the time of inspection plasterboard was unloaded in the opened ground area. This was explained as a temporary measure as waste was being sorted in the covered area at the time. Ensure you follow the permit condition 2.1.1 that states no wastes should be deposited where there are no sealed drainage systems.

Site infrastructure - Ongoing maintenance on site storage shed, damage to left side could cause pollution escaping out of boundary. Table 2.1 (d) states that covered areas need to be well maintained.

At the time of visit there was a large amount of waste inside green shed, this was said to be not a common working practice, and it was being monitored and controlled.

Emissions and Monitoring (W3E)

Litter around boundary kept to a minimum, recommended daily checks to ensure litter does not escape boundary. As per condition 6.5 prevent the escape of litter from the confines of the site - In the event litter does escape boundary to it must be retrieved as soon as practicable and no later than 1 hour after the end of the working day.

No breaches were identified on site during the site inspection. The Environmental Permit and EMS were available but ensure all staff have knowledge of its location. Separation of waste was in line with permit, however waste quantities in green shed were high and would need reducing for health and safety. See the FPMP guidance to help you with future planning. Some litter was spotted on the boundary, ensure waste does not escape perimeter by doing daily checks.
