### 4. Details of our assessment

On 24/05/2024, a discharge of grey water was made to the Sirhowy from a DCWW CSO.

This discharge was in breach of the discharge permit for the asset, as the discharge was not storm sewage and discharged in dry weather conditions.

**Breaches of permit condition as a result of the incident:**

- **1.1 General management**

1.1.1 (a) The operator shall manage and operate the activity in accordance with a written management system that identifies and minimises risks of pollution so far as is reasonably practicable, including those risks arising from operations, maintenance, accidents, incidents, non-conformances and those drawn to the attention of the operator as a result of complaints

**Justification:** Discharge was made to the Sirhowy during a period of dry weather, causing a low level impact to the watercourse.

**Action required by dates specified:**

Provide a written management system for the asset.
