4. Details of our assessment

This Compliance Assessment Report (CAR) has been raised by Paul Challender, reviewing Natural Resources Wales (NRW) officer to assess the submitted Annual Report for 2023.

The report was submitted via email on 03/04/24 following a request for an extension of the submission deadline by the operator that was granted. Going forward, please ensure that your appointed consultant is engaged early enough and that the annual report is submitted by the submission date stipulated by the permit.

The submitted Annual Report was compiled by the same provider as last year providing consistency. Data has been appraised for the year and has been trended for the year. Data that has annual submission requirements stipulated by the permit was submitted within this report, for example a surface emissions survey.

Below are observations made by the regulator:

Section 1.2.3 states that accepted waste is processed through the on site MRF. This statement appeared in the last annual report. The MRF has not been operational for several years and this is an inaccurate statement. Ensure the accuracy of statements made in next year's Annual Report prior to submission to NRW.

Section 2.2.4 states that high hydrogen sulphide levels have been detected across the gas field. This emphasises the need for effective gas control at the landfill.

Section 2.5.3 & 2.5.4 identified multiple point source emissions as part of the FID survey and states that improvements are being made to remediate the emissions sources. The operator should ensure that the remediation work is carried out effectively to minimise gas emissions.

Section 6 discusses gas migration and states that levels of methane and carbon monoxide are high in some perimeter boreholes indicating gas migration. NRW requested the operator to assess gas migration and report the findings and proposed solutions to NRW. The Annual Report states that a report numbered 5695-CAU-XX-XX-RP-V-0302 has been generated. This has not been received by NRW. An action has been applied in the Q1 Monitoring Returns CAR form to supply this document to NRW.

Section 3.2 discusses leachate levels and states that although not consistently compliant, there has been an improvement in leachate levels across the site. The general lowering of leachate levels at the site is encouraging.

Section 10 discusses the topographical survey. The survey chart's legend and contours are unreadable as presented in the report and no guide to the elevations represented by the contours is provided.
