4. Details of our assessment

This compliance assessment report (CAR) has been raised in relation to the Q2 2024 monitoring returns.

The Q2 monitoring returns were received on 10th July 2024 for discharges from W1 emission point in compliance with permit condition 4.2.3.

All reported parameters were in compliance with the Emission Limit Values (ELV's) applied by Permit Condition 3.1.2, Schedule 3, Table S3.1.

A Schedule 5 Part A notification was received on 26th June 2024 for a spillage of approximately 500 litres of raw effluent due to a failure of the automatic divert process. There was no release to the environment as the spillage was contained within the newly constructed bunded area.

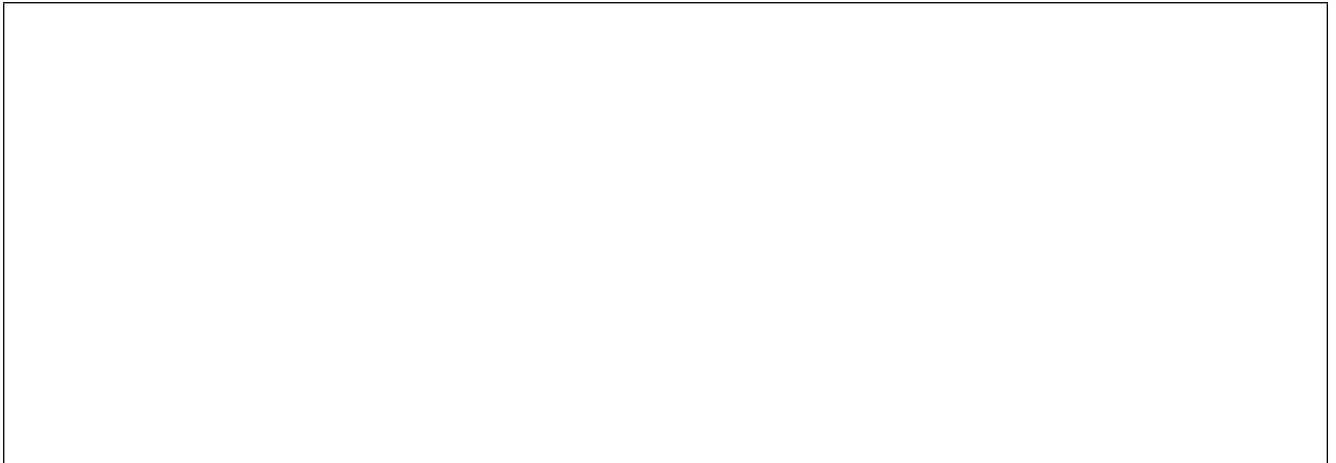
During the repair of the divert tank the automatic switching was bypassed to protect employees working within the tank. This was not turned back on during the re-commissioning process which resulted in the system failing to either switch to the divert tank or stop the raw effluent pumps from operating.

This demonstrates a lack of change management control over these processes and has resulted in a score as below.

Score C3, Permit Condition 1.1 - General Management

A Schedule 5 Part B was received on 28th June 2024. The following corrective actions have been implemented since the notification:

- The automatic switchover valve has been enabled on the HMI screen
- The actuator was checked and re-connected on the same morning. This actuator will enable the raw effluent pump to automatically stop if the balance tank reaches the switchover stage without switching over
- Implemented a Process Change Management Procedure
