4. Details of our assessment


This compliance assessment report (CAR) has been raised following a fire at the site (WIRS 2407631) that was reported to NRW by North Wales Fire and Rescue Service on 19/05/24. The fire occurred in the dust extraction system from the grinding process within the factory which is not part of the permit regulated by NRW.

The stream adjacent to the site was checked before we arrived on site and there was no apparent visual or olfactory evidence of contamination. On site we met the site owner and operations manager who took us to the outside area of the fire. They explained that the fire water had been contained on site by using woodchips as bunds. This material was then put back through the drying process. NWFRS used water on the fire and the wood material was not contaminated.

The bag filters within the abatement system were damaged by the fire but had since been replaced and the site was waiting for one section of the system to be repaired for it to become fully operational again.

Following the site inspection the Health Safety and Environmental Compliance Manager confirmed that the abatement was fully operational.

There were no other issues noted on site.
