## 4. Details of our assessment

### Compliance of Control of Pollution (Amendment) Act 1989

On Thursday 11<sup>th</sup> July 2024 Andy Prestt, Carriers and Brokers Officer; and Darren Morris, Licensing Officer – Bridgend County Borough Council visited JAB 93 – permit reference WP3498FW checking waste transfer notes, customer waste carrier licenses and site duty of care compliance processes.

From the sample of waste transfer notes inspected all haulier companies and companies that transport end of life vehicles onto the site have waste carrier licenses and waste transfer notes were all satisfactorily completed.
