4. Details of our assessment

Compliance of Control of Pollution (Amendment) Act 1989

On Thursday 11th July 2024 Andy Prestt, Carriers and Brokers Officer; and Darren Morris, Licensing Officer – Bridgend County Borough Council visited Bayliss Metal Recovery Ltd, Bridgend – permit reference BB3192FJ checking waste transfer notes, customer waste carrier licenses and site duty of care compliance processes.

From the sample of waste transfer notes inspected all waste companies that transport waste onto the site have waste carriers licenses. A list of Bayliss customers was printed out and when back at the office checks were made around business having waste carrier licenses. With some of the customers it was difficult to identify if it was a householders account or a sole trader account, no further action will be taken on these.
