4. Details of our assessment

This Compliance Assessment Report (CAR) has been raised in relation to the Q2 monitoring reports for 2024.

Q2 Monitoring Returns Air

The Q2 monitoring returns were received on 25th July 2024 for discharges from A6, A7 and A15 emission points in compliance with Permit Condition 3.3.1. and 4.2.3.

There are no permitted Emission Limit Values (ELVs) for these emission points.

Q2 Monitoring Returns Water

The Q2 monitoring returns for water were received on 25th July 2024 for discharges from W2 emission point in compliance with Permit Condition 4.2.3.

Suspended solids was in breach of the ELV of 80 mg/l specified in Schedule 3(b), Table S3.2. The result for suspended solids was 140 mg/l.

Schedule 5 notifications were received for these breaches on 3rd July 2024. Breaches of the suspended solids limit was reported for the following days:
