4. Details of our assessment

On Thursday the 27th of June 2024 a routine site inspection was carried out by NRW waste regulating officers.

At the time of the visit site was operational. The site manager was present and accompanied the officer during the site inspection.

The weather was dry and sunny.

W1A General Management

Condition 1.1.1 of the permit states: The operator shall manage and operate the activities: (a) in accordance with a written management system that identifies and minimises risks of pollution, including those arising from operations, maintenance, accidents, incidents, non-conformances, closure and those drawn to the attention of the operator as a result of complaints;

Mattresses were seen stored partially in the quarantine area and in the area which is marked as a gap on the site plan. Also, stockpiling increases the risk of fire, please ensure there are suitable gaps between the piles.

Waste streams ie wood, mattresses were stored not as described in the EMS - site plan.

Mattresses were seen falling over to the area where non-waste items were kept.
