4. Details of our assessment

This compliance assessment report covers the recovery operation at Synthite limited, Alyn Works, Mold, CH7 1BT between the 17th June 2024 and the 15th July 2024.

During the recovery operation and removal of paraformaldehyde subject to the fire on the 30th April, Synthite has been inspected regularly by NRW officers. Water samples have also been taken up and downstream of the site at the road bridge at Rhyd Y Golau and at Leadmills in Mold.

Site inspections were undertaken on the 17th June 2024 (CAR NRW0044680), 19th June 2024 (CAR NRW44680), 1st July 2024 and the 15th July 2024.

During the site inspections, no runoff was observed originating from the paraformaldehyde storage area which was subject to the fire and recovery operation. The recovery operation was observed to have been undertaken as per the techniques set out by the recovery plan. NRW has been verbally informed by the operator that it is seeking the lifting of the prohibition notice which was put into place by the health and safety executive. The operator plans to resume the storage of materials in this area once the prohibition notice has been lifted.

Data from water samples is still being collated and reviewed for discussion in a later compliance assessment report.

Action 1: Inform NRW when the prohibition notice is lifted to allow for inspection of the area subject to prohibition.

Action 2: Ensure the area around the steps at the paraformaldehyde storage compound remain clear to allow for inspection.

Action 3: Supply duty of care/ waste transfer notes for paraformaldehyde removed during the recovery operation to NRW for inspection by the **8th August 2024**.

Action 4: The operator is advised to obtain an engineers report for the integrity of the brick wall which separates the paraformaldehyde storage area from the River Alyn prior to the storage of materials in this location.
