4. Details of our assessment

I attended this site on the 12th July 2024 with my colleague Rob Harding, we were met by the Senior Operator and Operational Supervisor for Powys. The weather was cloudy but dry.

We walked the site from the intake to the outfall, discussing the process as we went. The permit for this site had been varied in Feb 2024 with progressively tighter limits over the next 5 years. We were advised that the site was due upgrades within the next AMP that had been prioritised as some of the pipework was showing

signs of aging – though not yet failing or causing pollution. There is no storm provision on site as this is managed at the nearby pumping station. The High Flow Filter was no longer operational, but this did not appear to be negatively impacting the treatment. The main filter bed media appeared to be in reasonable condition and the arms working as designed. The Humus tank had some duckweed on and grey scum but the discharge appeared clear.

Because of the nature of the site, the flows are managed by pumps and in the event of power failure a generator can be sourced rapidly from nearby as needed, but not kept on site.

We inspected the outfall which was largely overgrown but appeared to be clean and no indication of sewage fungus or grey discolouration. We also then inspected the Sewage Pumping Station (AN03464001) as there was DCWW operatives on site repairing the macerator. The storm outfall appeared clear and there is a small wet-well used for short-term storage before discharging to storm.

Summary: The site appeared tired and in need of the maintenance/repairs scheduled, but treatment has been within permit limits.
