4. Details of our assessment

On 17th April 2024 Angharad Clark attended Waterston Car Breakers in response to a fire which had occurred on 15th April 2024. I met with Phillip Horrocks, the site operator. The fire was started when an oxycetaline cutter was used to cut an axle. Mr Horrocks had doused the flame and gone to fetch more gas when the flame re-ignited and was rapidly spread around the yard by high winds. The burnt vehicle carcasses were stacked ready for removal. Please see photo attached. the perimeter fence was discussed. It does not currently extend around the entire site. Mr Horrocks stated that he will build a fence to secure the yard from all sides. Development of a Fire Prevention and Management Plan (FPMP) was also discussed. This is something Mr Horrocks stated he will look into after the physical aspects of the yard have been resolved.
