4. Details of our assessment

On 11th July 2024 Angharad Clark attended Waterston Car Breakers and met with Phillip Horrocks' brother and father.
All burnt vehicle carcasses have been removed from site and the number of vehicles stored on site is greatly reduced.
Construction of the perimeter fence is underway but has not yet been completed.
I provided Fire Prevention and Management plan (FPMP) guidance to Mr Horrocks' brother to pass on to Mr Horrocks.
No issues with site. Please continue to construct the perimeter fence and develop an FPMP.
