4. Details of our assessment

On 16th July 2024 Angharad Clark and Jolene Lewis attended Browns Waste Management site in Bynea for a routine inspection. It was a warm sunny day with a light north easterly wind. We met with the operator, Mathew Roderick.

Jolene Lewis discussed the Business Waste Regs which were introduced in April.

There was an increased volume of waste at the site. Mr Roderick explained that this was as a result of Atlantic Landfill temporarily closing. Waste movement has resumed and Mr Roderick has also arranged to take waste to Trecatty Landfill should Atlantic periodically shut over the summer.

Numerous seagulls could be seen on the waste. Please see attached photo.

Mr Roderick has recently changed the cover for the waste food storage area.

There was some pooling of rainwater in the centre of the site. Mr Roderick stated he will employ contractors to clear the drains again imminently.

Odour complaints about the site were discussed. Mr Roderick has assured me that should a cluster of odour complaints be received over the summer, he will hire in an odour suppressor to reduce any impact off site and is continuing to reduce the volume of waste on site.

On leaving site, Angharad Clark and Jolene Lewis went to the footbridge to the south west of the site. Odour was detected here and whilst it was not overpowering, it was unpleasant. This odour emission should be reduced as the volume of waste at the site is reduced.
