4. Details of our assessment

This was a pre-planned inspection carried out by Natural Resources Wales environment officers who were accompanied by a performance manager and Process operator from Dwr Cymru. The weather was dry.

The Process

The storm discharge comes from the inlet at Laugharne WWTW, the treated effluent from this works is covered by a separate permit and will be covered by a separate CAR form (BH0060005)

Storm flows are screened via a bar screen before entering the storm storage tanks to settle, this is then discharged to the environment. The discharge point was not inspected at the time of the inspection due to health and safety concerns given its location in the estuary.
