## 4. Details of our assessment

This compliance assessment report is being produced following a site inspection, conducted on Thursday 18th July 2024 by Luke Taylor (Waste Regulation Officer) and Gillian Coates (Hazardous Waste Regulation Officer) of Natural Resources Wales.

The weather at the time of the inspection was dry and sunny, with no wind. The site was operational but no activity was taking place.

There are two bays on site, used to dewater road sweepings. No treatment occurs on site, only storage. The drains of both were clear of any debris and all the waste was contained within the bays.

The site diary appeared up to day, with the site Technically Competent Manager, Trevor Tame, being on site at the time of the inspection.

No evidence of any non-compliance was identified.
