4. Details of our assessment

This Compliance Assessment Report (CAR) is being sent following the analysis of a compliance sample of the treated effluent taken on the 30th of May 2024. The sample

results came back with a solids result of 68mg/l, whilst the permit limit for solids is 60mg/l.

It's noted that this result is far better than the previous sample breach on the 11th of March 2024 (CAR form number: CAR_NRW0043864) and is only a marginal failure. As such this CAR form is being issued as Advice and Guidance on this occasion rather than a warning.
