### 4. Details of our assessment

Following a site inspection on 30th November 2023 in which we found no non-compliances and confirmation on 08/07/24 that there had been no changes on site, it was deemed that a visit would not be required for 24-25 and that a data/records review would suffice.

Following a data request on 08/07/24 the following could be assessed.

#### Assessment of 3 - Emissions & Monitoring

On 08/07/24 we received a photograph of the discharge from the outfall of the packet treatment plant. The discharge appeared clear, the discharge pipe was clean and the

discharge sample point appeared easily accessible as per requirement 3.3.1 of your permit.

#### Assessment of 4.1 - Records

You supplied us with evidence in the form of water meter records for the last 6 month period which demonstrated that you use and therefore discharge on average 4m<sup>3</sup> per day, with the highest monthly average being 5.18m<sup>3</sup>. This evidences that you are discharging less than your maximum permitted limit of 7.5m<sup>3</sup> per day.

You supplied us with the engineers site report from a service of your treatment plant, which included de-sludging, cleaning filter screen, and sampling of the discharge. This took place on 13/02/24. This evidences the fact that your system is kept clean well maintained and the report states 'All functions healthy'

The sample report results are as follows..

Ammoniacal Nitrogen - 0.386mg/l - *The permitted limit is 20mg/l*

Suspended Solids - <5.8mg/l - *The permitted limit is 30mg/l*

BOD - 23.5mg/l - *The permitted limit is 20mg/l so this indicates a possible non-compliance and should be investigated. (This is not a non-compliance as the analysis was not conducted by NRW and is not a UKAS accredited method)*
