4. Details of our assessment

This Compliance Assessment Report (CAR) has been produced following an operator request to temporarily use emission point W2 during and following rainfall whilst a section of the effluent discharge pipeline is replaced.

During the replacement there will be a period (currently scheduled as 26th July – 7th August) when the existing pipeline, linked to emission point W1, will not be available for use.

In the event of and following rainfall, emission point W2 will need to be utilised for the discharge of site surface water.

The temporary^[1] use of emission point W2 is approved on the basis of the below conditions:

- The emission point is used for rainfall dependant surface water drainage from site only (not process effluent streams, contaminated surface waters drainage, site sewerage, or cooling water blowdown).
- The operator provides notification to Natural Resources Wales (NRW) of the period when emission point W2 will be used - this to include start date/time and an end date/time - notification to be provided 24 hours in advance.
- The discharge route is inspected and confirmed to be unimpaired^[2] and fully intact prior to use. To this end, fresh mains water can be used to test the integrity of emission point W2 for site surface water drainage.
- On each day W2 is used, a 24-hour composite sample of the water must be taken (location to be agreed with NRW prior to sampling). This must be analysed for all parameters as detailed in Table S3.3 W2 plus Polychlorinated biphenyls (PCBs), and the results reported to NRW as soon as they become available to the operator.

^[1] 'Temporary' is defined as not permanent and lasting for only a limited period of time - the scheduled replacement works noted above. Operator to request an extension to this CAR if further time is required.

^[2] Operator has confirmed the sump that forms part of the discharge infrastructure has already been cleaned.
