4. Details of our assessment

This Compliance Assessment Report (CAR) has been produced following an operator request to extend the request to use an oxidation furnace within CAR_NRW0042557 beyond the stipulated deadline of 03/07/24.

The activities approved in CAR_NRW0042557 are still required to test wafers produced at the Newport and other IQE facilities but the oxidation furnace is not currently covered by the sites permitted operation.

An application to vary the permit (PAN-024249) to reflect the proposed activities (approved under CAR_NRW0042557) was picked up by Natural Resources Wales for duly making assessment on 20/05/24.

This CAR extends the deadline specified within CAR_NRW0042557, subject to the below caveats.

Condition 1 will now read: The activity approved under CAR_NRW0042557 is time limited to 12 months from 3rd July, 2024, or as soon as permit variation application (PAN-024249) is granted, refused or returned as not duly made.

Beyond the condition 1 (above), all other conditions in CAR_NRW0042557 remain.
