Information (W4B) Following a recent review of submitted waste returns, our records show that you have not submitted waste returns since 2018. It is noted that you are in the process of surrendering your permit, however if no waste has been accepted during a quarter you are still required to submit a **NIL return**. This has been scored as a **Category 3** breach of **condition 4.2.2** of your permit.
