NRW requested further information via the question below.

DCWW have now had the opportunity to respond to the below questions and have stated that the power outage and delayed response was due to 3rd party. NRW has now withdrawn the breach of permit condition 3.2.4.

Natural Resources Wales are requesting that a copy of the written management system which is required to be in place by Permit Condition 1.1.1.a

*On the 13/06/2024 DCWW experienced a power outage at the Abergele-Pensarn SPS (CM0153801), this power outage was communicated to NRW by OPNOT 290424043.*

*The duration of the unplanned event was 2 hours from 0430 – 0630. As a result there was a break in EDM monitoring which is a breach of permit condition 3.2.4.*

*NRW are requesting the following information from DCWW.*

*1, Did the power outage result in any emissions to water/spill to the environment?*

*2, Does the site have a standby generator?*

*2a, If yes, is there reason this generator was not brought online when the mains power was severed?*

*3, NRW are requesting an investigation be carried out to ascertain the reasons for the power outage and to put in place actions to prevent further blips in EDM recording.*

*NRW will consider the enforcement response to the non-compliance on response of the above queries.*

## Important information
