## 4. Details of our assessment

This Compliance Assessment report (CAR) follows the review of the 2023 Annual Report and associated monitoring data for Hafod Landfill. The Annual Report was submitted in accordance with condition 4.2.2 on 26/03/24 following an agreed extension.

Energy consumption at the site is required to be reported by Condition 4.2.2(b) and Table S4.3. 3,287 kWh of electricity were used during 2023.

Annual production/treatment, as required by Condition 4.2.3(c) and Table S4.2, has been provided. 19,404m<sup>3</sup> of leachate was disposed of offsite.

Combustion figures show 988,650 normalised m<sup>3</sup>/yr and 7,183,836 normalised m<sup>3</sup>/yr were combusted through the flare and gas engines respectively.

In accordance with Condition 4.2.2 (d-g), settlement figures were provided within the report between -0.5% and -1.9%. The remaining void was calculated in December 2023 at 1,930,918m<sup>3</sup>.

Landfill gas yields averaged c.933m<sup>3</sup>/hr during 2023.

Annual emissions testing for both engines (Engine 1 & Engine 3) was completed by a third party MCERTS accredited test house on 19/09/23. Although Total VOCs were above the permitted Emission Limit Value (ELV) included in Table S3.2, once the landfill gas tolerance figures from LFTGN08 were applied, they were within the permitted ELV and therefore compliant. All other values were within the permitted ELVs and therefore compliant.

Annual emissions testing for the landfill gas flare was completed by a third party MCERTS accredited test house on 01/12/23. All parameters were within the permitted ELVs and therefore compliant.

Trace gas analysis emissions monitoring was completed by a third party MCERTS accredited test house on 19/09/23.

Surface emission surveys were carried out on three occasions (March, May and November) during 2023 using a Flame Ionisation Detector (FID) to detect gas concentrations over the surface of the Site.
