4. Details of our assessment

Having received email clarification from DCWW on 24/10/2023 concerning said exceedance, please update us by 30 November 2023 as to how the modifications to the

final effluent channel are proceeding, along with any modifications you anticipate to the Klargester tank.

As per email of 27/11/2023 from DCWW requesting an extension to the 30 Nov 2023 deadline. Request granted, deadline now 1 February 2024 for update on improvement works.

Update received via email from DCWW 07/08/2024

Following the BOD sample failure in September 2023, DCWW have completed a number of improvements to site –

- Increased the number of operational site visits per week.
- Installed a solids monitor within the final effluent sample chamber.
 - In order to install a solids monitor, civils work was needed to upgrade the sample chamber and allow this monitoring to be undertaken.
- Installed stainless steel weirs to the final settlement tank for improved performance.

It has been assessed that operations will not be delivering modifications to the klargester tank at a local level due to the high costs and have listed this as a risk in our investment register for future funding. However we are confident the mitigation stated above will help to prevent future re-occurrence of a BOD sample failures.
