## 4. Details of our assessment

The Waste Regulation Higher Education Officer Dafydd Evans and the Waste Regulation Officer Magda Leonowicz went for a site inspection of the permitted site EPR/NP3595FM on the 18th of July 2024. The purpose of the visit was to carry out a routine compliance check. The weather was sunny, warm, and dry.

The officers could not enter the site as the access was restricted, the gates to the site were locked and secured but they could see the yard through the gates. The site appeared to be unoccupied. No waste or evidence of operations were observed. The officers took photographs of the yard through the gate and outside the gates then left the site. The photographs from the visit have been included in this report below.
