4. Details of our assessment

On Sunday the 7th of July 2024, NRW received a report (WIRS 2410236) that the long sea out fall on West shore, Llandudno was discharging via a "crack" in the pipe, NRW through its Incident Communication Centre (ICC), sent a POLFAX to Dwr Cymru/Welsh Water.

Dwr Cymru on the 8th July 2024 carried out a survey of the GRP pipe and on inspection they

discovered a 250mm break in the asset.

As per permit Condition 2.3 of the permit for this site, the GRP and the discharge that took place through the opening, there has been a permit breach, in this instance NRW are issuing Dwr Cymru with advice and guidance as part of this CAR form.

NRW are requesting that Dwr Cymru carry out a full inspection of the GRP to identify and make good any defects.

On the 30/07/2024, DCWW informed NRW that the GRP pipe and been fully repaired.
