The Compliance Assessment Report (CAR) has been generated by the Natural Resources Wales (NRW) Regulating Officer to comment upon the Q2 Monitoring Returns.

### **Q2 Monitoring Returns.**

Q2 2024 (April - June) monitoring results were submitted to NRW on 08/07/24 in accordance with Condition 4.2.3.

### Emissions to Water - Emission Point W1.

Emissions to water for Q2 were tested on 19/04/2024, 14/05/2024 and 15/06/2024. All parameters were within the emission limit values (ELVs) defined in the Permit (S3.2).

### **Actions.**

There was an action in the previous CAR (reference NRW0043993) requiring confirmation, that the repair of the collapsed drain was undertaken by 30 June 2024. Confirmation has yet to be provided. **Evidence to be provided to NRW by 30 August 2024.**
