On the 27/06/2024. DCWW reported via OPNOT (270624105) that the Llangernyw SPS (CG0179701) had, had an issue with the outlet telemetry reader.

NRW are requesting that DCWW carry out a full investigation to ascertain the reasons behind the telemetry issues that the SPS.

The following questions are also presented to DCWW.

Was there an impact to the environment as a result of the issues at the site?

Can DCWW inform NRW what was the reason for the telemetry issues at the SPS?

What are DCWW proposing to remedy the telemetry issues at the site?
