During the inspection I was accompanied around the site by site Foreman Les Davies.

General

The site was very busy but in most cases waste was well managed and evidence of good segregation could be seen.

Waste Storage

Wood waste

Whilst the wood waste is stored in a bay, the bay was almost at capacity, Les did explain that the 'chipper' was due in in the next week or so to process it. This is not a non-compliance but the operator should ensure the quantities of waste wood are reduced at site to ensure it does not become an issue.

Plastics

Your Fire Prevention and Mitigation Plan (FPMP) states that plastics should be stored in a container, section 5.5 of your FPMP states:

5.5 Plastics

The storage of plastic destined for onward recycling is in 40yd hooklift skip/containers sited along side the weighbridge, as marked on the site plan. Once the skip/containers are full they are removed from site for onward recycling.

Whilst there was a hooklift container on site for plastic, a large amount of plasticsilage wrap was being stored on the ground and around it as can be seen in this photograph:



This is a breach of condition 3.4.1 of your permit and has been marked down as a category 3 non-compliance.

Les Davies did explain that Birch were due to collect the wrap in the next few days. Please ensure all plastics are stored as stated in your FPMP.

TCM

David Mackay is the Certificate of Technical Competence holder for the site. The last record we have of his WAMITAB qualification shows the current period of continued competence expired in February 2018. Can you please forward us a copy of a current certificate.

During our last inspection we were informed Les Davies and Stephen Thomas were undertaken their WAMITAB qualifications and were awaiting certification. Can you please forward us evidence of certification or an update on their qualifications so we can update our records.
