On 17 August 2018 NRW were informed that Kier were having potential issues with their offtake of baled plastics and as a result you are currently storing waste outside of your permit boundary.

Thank you for informing us, this has ensured you have complied with permit condition 4.3.1. You have breached the permit condition 2.4.1 by storing wastes off the permitted area.

A1 – Permitted Activities – Specified by permit – CAT 3 – Permit condition 2.4.1

You have been given a CAT 3 breach under the above condition as you informed us that waste (namely plastic) was stored off the permitted area.

2.4.1 The activities shall not extend beyond the site, being the land shown edged in green on the site plan attached to the permit.

You informed me this could be an issue until early September and you are currently looking for outlets for the plastics.

ACTION: Ensure all wastes are stored within the permitted boundary by 23/09/2018

Any compliance criteria not highlighted in the above summary should be considered as not assessed.
