## 4. Details of our assessment

This Compliance Assessment Report (CAR) follows the review of information submitted in response to Action 1 in CAR\_NRW0042471 which relates to Improvement Condition 9 of the permit.

Action 1 required the operator to 'Provide NRW with realistic dates for end of life replacement for all units that contain refrigerants that are not in line with BAT.'

The operator provided the following response to NRW on 30/05/24

'Since our submission to the improvement condition, 2 of the R22 units have now been removed. It is anticipated that the 4 remaining R22 units and 1 R422d unit will reach end of life in 5 years. We will review these at the end of 2028 (or sooner if there are any issues with the units).'

NRW considers that the requirements of Improvement Condition 9 have been met.
