4. Details of our assessment

Officers Harry Warburton and Alex Grabham attended to inspect discharge permit AN0415001.

We inspected the private package treatment plant location, all was in good working order with no signs of odour or overspilling. The final effluent chamber was lifted and it was running clear with no signs of poor water quality.

The outfall to the Nant Llanccarfán was observed and there was no evidence of any impact to the stream.

The owner mentioned it gets emptied every year and only services a few people at most so

has minimal inlet flows.
No actions required.
