## 4. Details of our assessment

The impoundment licence to abstract water for unnamed tributary of Blaen Nanmor at Cwm Gelli Iago, Nant Gwynant, Caernarfon is due for renewal on the 31<sup>st</sup> March 2025. Laura Jones from the Conwy Environment Management team and Sioned Jones from the Dwyfor and Meirionnydd Environment Management Team visited the site on the 2<sup>nd</sup> August 2024 and met with the caretaker Mr Wynn Jones.

### **Name of Inland Water to Be Impounded**

Inland water (stream) known as unnamed tributary of Blaen Nanmor at Cwm Gelli Iago, Nant Gwynant, Caernarfon.

No issues were identified

### **Point Of Impoundment**

At National Grid Reference SH 63596 47761 marked 'Point A' on the map.

No issues were identified

### **Manner and Extent of Impoundment**

Intake works consisting of a new concrete weir, Coanda screen with 1 millimetre perforations, HOF notch and gravity feed penstock pipe with an external diameter not exceeding 225 millimetres, controlled by a spear valve, and integrated forebay tank, in accordance with the specifications and drawings.

No issues were identified, all measurement taken on site were within these measurements.

### **Further Conditions**

For the purpose of this licence, references to 'intake works' shall mean all works consisting of a new concrete weir, Coanda screen with 1 millimetre perforations, HOF notch and gravity feed penstock pipe with an external diameter not exceeding 225 millimetres, controlled by a spear valve and integrated forebay tank.

The licence holder shall construct, operate and maintain the intake works in accordance with the specifications and drawings referred to in condition 3.1 of this licence and keep them free from leakage and obstruction at all times

No issues were identified, all measurements taken on site were within those on the licence. The intake works were free from leakage and obstructions.

The scheme has been built to the permit, it is very well maintained. I would like to thank Mr Wynn Jones for taking the time during the visit to take us to the weir structure and don't see any issues with a new permit being issued.
