On the 12th of August 2024 NRW Officer Nathan Owen and SEO Euryrn Roberts visited the Rowen STW . On site we were met by the DCWW NW Catchment Manager and the NW Operational Supervisor.

The weather on the day was warm and sunny it had been raining prior to our arrival.

The site was inspected from inlet to the final effluent sampling point. We did attempt to inspect the final outfall however due to over grown hedge roes on private property it was not possible.
