### 4. Details of our assessment

This was a pre-arranged inspection to complete an Operator Monitoring Assessment (OMA) for Water.

The Environmental Manager was the host for the site visit, accompanied by the Technical Director.

#### **OMA Audit**

The OMA Audit covered discharge at W1. Effluent from the on-site effluent treatment plant (ETP) discharges to the River Teme via a lined swale system.

The sites management system of water emission monitoring is of a high standard. A UKAS accredited external laboratory is used for monitoring of weekly samples, in accordance with S3.2 of the Permit. Continuous monitoring of temperature and pH is in accordance with the Permit. The flow meter whilst not MCERTS certified has been agreed for use with with NRW.

The site achieved an overall score of 80%.

#### **Recommendations**

Based on the audit, the recommendations for improvement are as follows:

- A specific monitoring /sampling schedule is not included within the EMS documentation. It is recommended that the operator prepare a sampling schedule which is accessible to those appointed to undertake the water monitoring.
- The EMS does not include specific requirements for sampling and scheduling for external MCERTS laboratory analysis. It is recommended that the operator prepare a work instruction /procedure for sampling and scheduling for external MCERTS laboratory analysis.
- The sample point is accessible but is not clearly labelled. It is recommended that the operator clearly label W1 sample point to avoid the risk confusion in the event that alternative operators /3<sup>rd</sup> party contractors are required to undertake the monitoring in the future.
- Original laboratory results, ideally in PDF format, to be provided when submitting quarterly and annual return reports. Submission date deadline for quarterly returns is within 28 days of the end of each reporting period.
