4. Details of our assessment

AMENDED ON THE 16/08/2024 TO REFELCT PERMIT CORRECT PERMIT CONDITIONS.

On the 12th of August 2024 NRW Officer's Nathan Owen and SEO Euryrn Roberts visited

the Rowen CSO. On site we were met by the DCWW NW Catchment Manager and the NW Operational Supervisor.

The weather on the day was warm and sunny it had been raining heavily prior to our arrival.

The CSO was not in operation at the time of our visit, however at the time on inspection there was a clear crack/split on the storm weir join from the inlet, this was allowing effluent to run from the inlet into the CSO in non-storm conditions.

NRW are requesting this minor defect be remediated by no later than the 31st of August 2024.
