### 4. Details of our assessment

Following the incident report (WIRS 2410709) we received on 20/07/24 it became evident

that the screen on the Combined Sewer Overflow at Llanelli - Head Post Office was not compliant with the conditions of Table 3.3 in the permit.

This has already been discussed with the area Pollution Technician at DCWW who has confirmed that it has been added to DCWW's 'investment manager for future investment'.

**Action: Install new screen so that it is compliant with the conditions of Table 3.3 in the permit.**
