4. Details of our assessment

This Compliance Assessment Report (CAR) follows the review of Q1 monitoring returns (January-March 2024) for emission points W1, W2 and S1. This data was received by NRW on 24/04/24, which is within the timescales required by the permit.

All parameters were within the permitted Emission Limit Values (ELVs) and therefore compliant.

Chemical Oxygen Demand (COD)

On 28/02/24, emission point W1 recorded a maximum Chemical Oxygen Demand (COD) value of 48mg/l vs a permitted ELV of 70mg/l.

On 10/03/24, emission point W2 recorded a maximum COD value of 46mg/l vs a permitted ELV of 70 mg/l.

Biological Oxygen Demand (BOD)

On 28/02/24, emission point W1 recorded a maximum Biological Oxygen Demand (BOD) value of 15.45 mg/l vs a permitted ELV of 30 mg/l.

On 10/01/24, emission point W2 recorded a maximum BOD value of 8.66 mg/l vs a permitted ELV of 30mg/l.

Total Suspended Solids (TSS)

On 11/03/24, emission point W1 recorded a maximum Total Suspended Solids (TSS) value of 34 mg/l vs a permitted ELV of 50mg/l.

On 14/02/24, emission point W2 recorded a maximum TSS value of 35 mg/l vs a permitted ELV of 50 mg/l.

Emissions to sewer

Emission point S1 recorded the following maximum values:

COD- 575mg/l - 20/01/24

TSS- 286 mg/l - 15/02/24

Flow (m³/day)- 955 m³/day- 29/02/24

There are no permitted ELVs associated with emission point S1.
