4. Details of our assessment

This Compliance Assessment Report (CAR) has been raised in relation to the Q2 2024 monitoring and waste returns.

Q2 Monitoring Returns - Air

The Q2 monitoring returns were received on 26th July 2024 for emissions from A1, A12 and A13 emission points in compliance with the timescales stipulated in permit condition 4.2.3.

Reported parameters for A12 and A13 were in compliance with the Emission Limit Values (ELV's) defined in Schedule 3 table S3.1.

The results for the A1 emission point was above the ELV of 5mg/m³ for particulates.

A Schedule 5 Part A was received on 9th February 2024 detailing the technical problems the site is experiencing with the A1 continuous emission probe which is ongoing.

Scores may be applied once further information and a Part B is received.

A further Schedule 5 Part A was received on 23rd July 2024 for a breach of the ELV on emission point A1 for particulates for the daily average. This was attributed to driving rain impacting on the dust probe:

No evidence of any alarms coming from the probe or bag plant

Bag filters were checked and no leaks found

No changes to production processes or scrap fills had occurred.

The site is currently evaluating the potential to reduce the impact from weather to the dust probe.

Q2 Monitoring Returns - Water

The Q2 monitoring returns were received on 26th July 2024 for discharges from W1 emission point in compliance with the timescales stipulated in permit condition 4.2.3.

Reported parameters were all in compliance with the emission limit values (ELV's) defined in Schedule 3 table S3.2.

Q2 Waste Returns

The Q2 waste returns were received on 26th July 2024 for wastes accepted for the quarter April to June 2024 within the timescale stipulated in permit condition 4.2.5.

The waste returns were reviewed and there were no issues identified.
