4. Details of our assessment

Withyhedge Landfill

Resources Management (UK) Limited (RML) operates Withyhedge Landfill under the provisions of an EPR Permit (MP3330WP).

The site is a non-hazardous landfill and was constructed in two phases. Phase 1 accepted waste from 1985 until its closure in 2006. Phase 2 is the current operational area, although no waste is presently being accepted at the site.

Introduction

An unannounced site inspection of the landfill was undertaken on 24th July 2024. The site inspection included observation of Cell 9 construction works, a visit to the surface water management lagoons and gas utilisation plant (GUP).

Odour Assessment

NRW officers undertook an odour assessment prior to attending the landfill site. Assessment was undertaken at locations within the local community, including locations within Spittal, Crundale and Poyston Cross, Treffgarne. Weather conditions during the inspection, overcast with intermittent fine rain, 17°C and light South-Westerly wind.

No landfill associated odours were detected offsite during the assessment, findings recorded on odour assessment report.

Site Visit

Construction work on phase 2 of the surface water management lagoon continues at the Northern side of the landfill. Heavy plant equipment used to shape and form the settlement lagoons prior to D2 discharge point.

Gas Management System

During the inspection the sites flare, and emergency flare were undergoing maintenance and therefore not functioning. Two of the sites gas engines running during visit. Performance data for the engines retrieved by NRW officers.

During the inspection NRW officers did not detect any landfill associated odour.

Landfill Engineering

Cell 9B basal liner completely laid since previous site visit. Heavy plant being used to remove topsoil and shape the area for Cell 9C development.
