**4. Details of our assessment**

Control of Pollution (Amendment) Act 1989

On Wednesday 26<sup>th</sup> June 2024 Andy Prestt, Carriers and Brokers Officer visited Sims, Cardiff – permit reference AB3993ZF checking waste transfer notes, customer waste carrier licenses and site duty of care compliance processes.

From a sample of waste transfer notes there were multiple businesses / scrap metal collectors that did not have waste carriers licenses.

Your management system must explain how you will comply the requirements of waste Duty of Care. This includes ensuring any waste carriers you accept waste from are registered. You must also complete a Waste Transfer Note for each load of waste transferred to your site, and this must include all the required information.

During our inspection, we noted that you were not complying with these requirements. As a result, we have scored a breach against this condition. You must ensure your management system includes procedures explaining how you will comply the requirements of Duty of Care and you must operate in line with these procedures,. The breaches we identified were that waste carriers licenses were not being checked for external business that uses the site to dispose of waste.

## Important information

### Legal status of this report

Your permit is issued to you under the Environmental Permitting Regulations. You have a responsibility to comply with the conditions of your permit and prevent pollution/harm of the environment.
