4. Details of our assessment

This was an unannounced inspection primarily to check that the terms of the site permit are being followed. We were greeted by a worker on the site who signed us in and introduced us to the site manager/TCM, who accompanied us on part of the visit.

The weather was dry, mild and overcast.

The site identification board was clearly visible, clean, undamaged and displaying all required information.

The site diary was checked and was up to date with all relevant entries completed.

Upon entry to the site, users benefit from being greeted and advised by a member of staff.

All waste types were correctly segregated and signed and contained in their respective skips/containers.



An area has been set up for users to leave waste paint. This has large clear signs providing instructions to users.



Storage of WEEE



Several fridge/freezers were standing uncovered in the open. This was pointed out to the site manager who was informed that this would be mentioned in the compliance assessment report form. As per schedule WEEE 2 directive requirements, WEEE directive Annex III, the WEEE should be stored on an impermeable surface with sealed drainage and also have weatherproof covering.

Action: Please ensure that all WEEE is stored appropriately. Should there be no appropriate storage available, the site should refuse to accept such waste

The officers had a look around the rest of the site and saw no issues of non-compliance. Generally, the site is tidy, functioning well and observing the terms of the permit.
