4. Details of our assessment

This compliance assessment report follows the submission of the Q1 2024 and Q2 2024 monitoring returns.

As detailed in CAR NRW0042311 the HDU and associated infrastructure ceased operation in June 2023 and was removed during Q3 2023. Agreement was made relating to the associated monitoring requirements at that time.

Efficacy monitoring is no longer required.

Air emissions monitoring is no longer required.

Emissions to sewer were submitted in accordance with Condition 4.2.3:

- January - March 2024 - flow readings submitted 26/04/2024
- April - June 2024 - flow readings submitted 02/07/2024

At this time the Operator has utilised the area where the HDU was for storage and transfer operations. Therefore there is no requirement for the continued submission of either efficacy or air emissions data. Other reporting requirements remain and should be submitted as detailed in the permit.

Nb: NRW remind the Operator that should they wish to recommence any of the activities in Table S1.1 that have currently been removed, prior discussion with NRW is needed to ensure that these are compliant with all relevant legislation at the time, including the relevant BAT requirements.
