4. Details of our assessment

Please note this CAR form also relates to Impoundment WA-056-0036-009

On 13th August 2024 I attended the site with my colleague who was shadowing. The weather was dry, warm and overcast. This was an unannounced visit with most rivers in typical summer levels, with some light rain-showers the day before.

We approached the turbine house first, but were unable to confirm the outfall location so no screening could be confirmed - this will need to be confirmed by yourself with photographic evidence. There was no sign of any discharge at the time of our visit.

We then drove up to the intake where the scheme was as shown and appeared to be operating as designed, no flow over the intake and all through the HoF notch. Some of the fish easement elements appeared to be worn but there was no indication they needed replacing at this stage.

On returning to the office it has been identified that no Abstraction Returns have been submitted since 2019, which is a breach of permit condition 8.1. You will need to submit returns for the last two years (April 2022 - March 2023 and April 2023 - March 2024) no later than the 27th September 2024. If you are unable to use the online portal for this, you will need to contact the Water Resources Returns team to request paper copies.

Summary of actions:

- Confirm the location of the outfall in relation to the turbine house
- Confirm appropriate screen is on discharge pipe with photographic evidence
- Submit abstraction returns for the last two years.
