4. Details of our assessment

This Compliance Assessment Report (CAR) is an assessment of the 2024 Q2 reporting submission required by the permit of the operator, Cwm Environmental Limited - Nantycaws HCI Waste Transfer & Treatment Facility.

The Q2 monitoring returns has not been submitted to NRW in full and is now outside the reporting window as required by condition 4.2.3 of the permit. This represents a non-compliance with the environmental permit under permit condition 4.2. **This has been assigned a non-compliance score of C3 under sub-criteria IR4B Reporting**

To date only the Bioaerosol monitoring has been submitted for this reporting period.

The information required is shown in Schedule 4 of the permit.

From a review of the limited information submitted, Bioaerosol monitoring was undertaken, and the results were compliant with the stipulated emission limit required by permit condition 3 Emissions and monitoring.

ACTION - Monitoring returns must be provided to NRW in accordance with the timescales required by the permit. Where necessary the Operator must review the sampling, testing and reporting currently undertaken and where appropriate, modify to ensure that reporting to NRW is undertaken within the required timescales.
