4. Details of our assessment

Compliance of Control of Pollution (Amendment) Act 1989

On Tuesday 27th August 2024 Andy Prestt, Carriers and Brokers Officer visited RR Davies Ltd – permit reference MP3894VQ checking waste transfer notes, customer waste carrier licenses and site duty of care compliance processes.

W1A General Management – C3 breach of permit condition

Your management system must explain how you will comply with the requirements of waste Duty of Care. This includes ensuring any waste carriers you accept waste from are registered. You must also complete a Waste Transfer Note for each load of waste transferred to your site, and this must include all the required information.

During our inspection, we noted that you were not complying with these requirements. As a result, we have scored a breach against this condition. You must ensure your management system includes procedures explaining how you will comply the requirements of Duty of Care and you must operate in line with these procedures,.

To comply with your duty of care requirements you must check waste carrier licenses of all businesses, sole traders and scrap metal collectors transporting waste onto your site. You must also ensure full names and addresses (property numbers / street name / town / post code) are recorded on the transfer note and that for businesses waste carrier numbers are stated on each transfer note.

If a business is not registered as a licensed waste carrier and refuses to do so Andrew.prestt@naturalresourceswales.gov.uk is to be contacted to get the business to sign up as a waste carrier.
