4. Details of our assessment

Bio-aerosol monitoring

Bio-aerosol monitoring was undertaken in accordance with Condition 3.7.1 (a). The permit requires bioaerosol monitoring to be undertaken twice a year.

Table S3.1 specifies limits for bio-aerosol concentrations as:

- Total bacteria - 1000 cfu/m³
- Aspergillus fumigatus - 500 cfu/m³
- Gram negative - 300 cfu/m³

The monitoring was undertaken on 20th May 2024. Bio-aerosol concentrations were compliant at all sampling locations during this monitoring exercise.

Q1 and Q2 2024 Waste returns

Waste returns were submitted for Q1 and Q2 in 2024 in compliance with Permit Condition 4.2.2. Waste returns were reviewed with no issues identified.
