4. Details of our assessment**Monitoring Returns**

Air emissions monitoring for the A1 stack from the air treatment system is required to be undertaken once every 6 months. Monitoring was undertaken on 16th May 2024 in accordance with Permit Condition 3.5.1 (a) and results were submitted to NRW on 18th June 2024.

The results for dust and TVOC were compliant with the emission limits specified in Table S3.1. The result for odour was compliant with the emission limit taking into account the uncertainty values reported.

Bio-aerosol monitoring for the A1 stack from the air treatment system was undertaken on 20th May 2024 in accordance with Permit Condition 3.5.1 (c). The results were compliant with the emission limit values specified in Table S3.4.

Q1 and Q2 2024 Waste Returns

Condition 4.2.5 requires that quarterly waste returns for the previous quarter shall be submitted within one month of the end of the reporting period. Waste returns were submitted for Q1 and Q2 in 2024 in compliance with permit condition 2.3.2 (a), Schedule 2, Tables S2.1 and S2.2. The waste returns were reviewed with no issues identified.
