4. Details of our assessment

Unannounced site inspection undertaken by Michael Edwards of Natural Resources Wales to aid the in permit surrender process.

On site, officers discussed the current processes on site with the site employee who confirmed that the operators purchase railway sleepers and then sell them on to customers for use.

The yard was in good condition with no wastes stored on the yard, only sleepers that are stored prior to sale.

The site infrastructure was in good condition. And no evidence of pollutants were visible during the inspection.
