Please repair the cracks causing the seepage on the primary tank. 2 cracks were identified

during the visit. Please see photograph below.

We note that waste was escaping the skip and also leaking from the skip on site that holds the debris from the filter. Please explore an alternative method to handle this waste.

Please ensure all repair work is completed by the 31/10/24
